#### 4. Introduction of the content of the release

This release is backwards compatible for REST API, SOAP API 3.0 and 3.1 and Widget interface.

The main enhancements refer to the ability to support new document types for ESG, Insurance companies and Cryptos. Additional instrument identifiers are supported for Cryptos and FIGI. GUI user get the possibility to download a document direct from manufacturers page if the link cannot be accessed by DocHub directly.

All changes are **non-destructive** to the current version and there is no immediate action required.

To use new features, please foresee in your planning the migration to the REST API.

##### Service Improvements for Distributors:

- Additional document types
- Additional Instrument Identifiers
- Direct access to the link if DocHub cannot download a document for GUI users

##### Service Improvements for Suppliers:

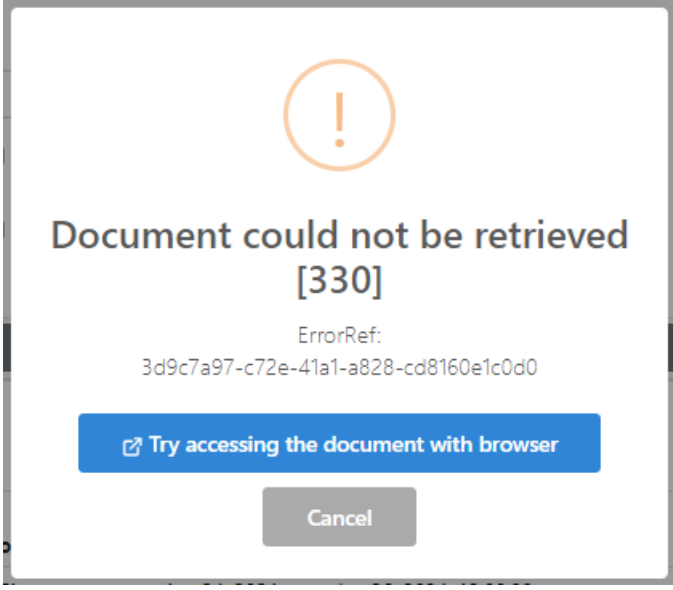
